

## THE CANADIAN FOUNDATION FOR ECONOMIC EDUCATION TO STAGE FINANCIAL LITERACY PROGRAM FOR NEWCOMERS TO CANADA

Select communities across Canada to host workshops for Canadian newcomers with an emphasis on the thousands of recent refugees from Syria

OTTAWA, ON. (January 23, 2017) – The Canadian Foundation for Economic Education (CFEE), with funding from the RBC Foundation, will be staging a financial literacy program for newcomers and recent immigrants to Canada. The program has two primary platforms – financial literacy workshops in select communities across the country and a dedicated website (Managing Your Money in Canada – www.mymic.ca) for Canadian newcomers and immigrants.

Working with community based organizations, CFEE plans to stage multiple financial literacy workshops in seven Canadian communities. To date, workshops are planned for Ottawa (January 21st and 23rd) and Windsor on January 25th. Other dates and locations will be finalized in the coming weeks. The workshop materials are available in English and French and, for the first time, in Arabic recognizing the language limitations of the Syrian refugees. Over 28,500 Syrian refugees have arrived in Canada since November 2015, settling in close to 300 communities across Canada. CFEE expects that 75% of the participants in its 2017 financial literacy workshops for newcomers will be Syrian refugees.

The purpose of the workshops and website is to help newcomers address their financial information needs, answer their questions about money and ultimately build their financial knowledge. The need for such support is now more acute than ever, given the thousands of Syrian refugees that have arrived in Canada in the past year and the fact that many of these refugees are now coming off federal government financial support.

CFEE covers all costs associated with the workshops and website through the support of the RBC Foundation.

The 2017 program marks the fourth consecutive year that CFEE has worked with community partners to deliver the financial literacy program for newcomers and recent immigrants to Canada. In its third year in 2016, CFEE staged 16 financial literacy workshops in 5 communities in Canada.
